Conditions

- Your business is required to hold Public Risk Policy with cover of NOT LESS than \$10,000,000.00, a copy of Certificate of Currency is to be provided with your application for Trade Space. If you do not hold a current Public Liability Policy, a fee of \$22.00 will apply to your application.
- A 25% deposit will be required at time of lodging application. This fee will be refunded if you provide notification of cancellation BEFORE 4pm Friday 3rd February 2012
- When you or members of your team arrive at the Showground, please attend to the Secretary's Office (beside the Grandstand) to sign the Waiver Form, and also to collect any other information/documents and passes.
- Electrical Notice.** Any exhibitors intending to bring electrical equipment to the Showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor. This is essential for the safety of yourself, your fellow exhibitors and the general public and is a requirement of the Occupational Health and Safety Act of 1989. The Act imposes very severe penalties in the event of non-compliance with its provisions. Any exhibitors who do not comply will not be allowed to exhibit at the Glen Innes Showground. **Please check all your electrical equipment and leads before you arrive to avoid the occurrence of any difficulties**
